You may nominate a candidate for this award if you are an MFPA Full or Associate Member or an employee of an MFPA member. Self nominations are permitted.

- Involvement with the community, educational institutions and/or mentorship
- Committee and/or Industry Organization activities
- Achievements in research & development, market development and/or innovation
- Presentations, publications, papers, etc.
- Recognition received through other contributions
- General respect and admiration by peers
